Hindustan Latex Limited, Kanagala recognises employees as its biggest resources and assets. It aims at getting the total co-operation of its work-force. It has provided many labour welfare facilities to its workers.

STATEMENT OF THE PROBLEM:

The establishment of a 'welfare state' is the goal of all efforts of the Government in our country. The ultimate objective of a welfare state is the well-being of the society as a whole but at the sametime it must also be realised that a happy and cosntented labour force is one of the main pillars on which the edifice of large-scale industrialisation should rest. Therefore, the material progress of a country depends largely on the toil and labour of this significant section of the society. Provision of adequate amenities to this class of people in order to enhance the scope and importance of work which may elevate their happiness in increasing production.

The 'Labour Welfare Activities' of the employers in particular and of the State in general are not only conducive to an improvement in the conditions of the working class but are the best kind of investment to employers for promoting industrial efficiency.

Besides, labour welfare has tremendous potentialities for fostering good industrial relations.

Therefore, lookling into the significance and importance, Hindustan Latex Limited, Kanagala has been provided ng labour welfare facilities to its workers.

OBJECTIVES OF THE STUDY

The present stucy is undertaken with a view to attain the following objectives.

- 1) To examine the extent of the Labour Welfare Programmes of the Hindustan Latex Limited, Kanagala.
- 2) To explore and analyse the effect of those welfare measures on workers' attitudes.
- 3) To suggest suitable administrative measures for adoption.

SCOPE AND LIMITATIONS

The study concerned is an empirical study based on data collected from the workers and the management as well as from the published data. Hindustan Latex Limited, Kanagala is the largest manufacturer of contraceptive condoms in the country. It has two plants, one at Trivandrum and another in Belgaum. The present study has concentrated on Hindustan Latex Limited, Kanagala (in Belgaum District).

The present study is based on sample method. It was not possible to reach every worker in limited time. The sample was selected from different departments of Hindustan Latex Limited, Kanagala. A structured sample of 50 workers was selected from various departments:

viz:(i) compounding section (ii) moulding (iii) vulcanizing

(iv) Half-product (v) Inspection (vi) Quality Control (vii)

Packing (viii) Mechanical Workshop (ix) Electrical Workshop (x)

Boiler house sections with the help of random Number Tables.

The investigator has not taken the opinions of Officers and authorities. The investigator is compelled to depend only on the workers opinions. Interview schedule covers a number of aspects of Welfare activities.

METHODOLOGY;

This is an explorative study. Therefore, the interview schedule was used as tool for gathering data. The interview schedule was prepared in consultation with the executives of the organisation. The survey was conducted with the help of interview schedule, workers from different departments were selected as a sample.

Accordingly tables are prepared the data is analysed, conclusions are drawn on the basis of analysed data, some valuable suggestions are made at the end. Hindustan Latex Limited, Kanagala has following sections/departments.
