: PREFACE :

I] INTRODUCTION:

Co-operative sugar factories in Western Maharashtra have made impressive progress in the field of sugar production. These sugar factories were developed in the co-operative sector mainly with the intension that their development under local leadership, would also bring about area development of the region. The working of these co-operative sugar factories over the past years has proved that they are indeed the Growth Centres for rural development and transformation. Against this background the present study makes an attempt to examine the performance of the Shri Doodhganga Vedganga Co-operative Sugar Factory Ltd.,Bidri in its commitment towards area development and rural transformation in its area of operation.

II] OBJECTIVE OF THE STUDY:

The study attempts to examine the various development programmes undertaken by the co-operative sugar factory in its area of operation, to bring about rural development and change. The following are the main objectives of the study:-

 a) To Study the impact on sugarcane cultivation and productivity.

- b) To study the various programmes undertaken by the factory fot the benefit of member farmers like supply of agricultural inputs, supply of fertilizers, supply of new varieties of sugarcane seeds etc.
- c) To study the other development programmes initiated by the co-operative sugar factory on behalf of the State Government for overall rural development and for the benefit of the weaker sections of the farmers both members and non-members.

III] METHODOLOGY OF THE STUDY:

The study is divided into two parts. Data regarding various schemes implemented by the sugar co-operative under study as programmes of Area Development is analysed firstly. The necessary secondary data for this is based on secondary data published by the factory. For this the Annual Reports of the sugar factory under study were mainly relied upon. In addition certain office records of the factory were also consulted to get the necessary data. The period of the study is 1980-81 to 1990-91 for which data was available to the researcher.

To study the benefits of the Area Development Programmes in preliminary form a sample survey of member farmers as well as non-member farmers was undertaken into villages

coming under the area of operation of the sugar factory under study.

The two villages selected for sample study were village Konawade and village Naratwade both located within a distance of 6 to 7 Kms. from the factory site.

The list of shareholders supplied by the factory office was used as the basic sampling frame. The list of shareholders from both the villages was taken and from both the villages 14 percent of the sample was covered for the study. For selecting the sample the technique of interval (systematic sampling) was followed. The first respondent was selected from a table of random numbers and the remaining vere selected at a regular interval of 14. Out of the total shareholders of 114 from village Konawade a sample of 16, was selected for interview and out of total shareholders of 348 of Naratwade village 50 were selected for interview. The interview method was adopted to get the response from the sample size and the information regarding benefits derived from the various programmes implemented by the factory was thus collected. The interview of the respondents was carried out during the months of January-February, 1993.
