ORGANIZATIONAL STRUCTURE OF CO-OPERATIVE FACTORIES1. INTRODUCTION

After presenting the Methodology of the study, ~~an~~ attempt has been made to describe the organizational structure of different co-operative factories at Ichalkaranji.

2. CONCEPT OF ORGANISATION

In ordinary language organization has two meanings "one is dynamic and consists in the process of adjusting various elements among themselves in order to perform a function. The other meaning is static and consists in the result of organization, business organization and military organization etc. In this sense the term organization refers to the whole of organization industry and also the operations which brought about that organization. Another respective meaning of organization in the activities addressed to achieve production in accordance with the aims of industry."¹

Organizations have become so important that people are today, members of one or the other organization and spend lot of their time in them. Men live in organizational environment which even makes their behaviour organizational. So much so, the problem of organization has become the focus of all human activity.

Commonly organization means putting the things in working order. Organization is the form of every human association for the attainment of a common purpose. Organization involves arrangement of personal to

achieve some set objectives through allocation of functions and responsibilities. Organization consist of the relationship of the individual to individual and of group so as to bring about orderly division of labour. All said and done organization is planned system of co-operative effort in which each participant has a role to play and ^{to perform} duties.

3. ORGANIZATIONAL STRUCTURE OF CO-OPERATIVE FACTORIES

The following part deals with the presentation of organizational structure of co-operative factories.

The shareholders elect the board of directors and the board of directors elect the Chairman and Vice-Chairman of the factory. This pattern is followed in all the co-operative factories.

Now the organizational structure of co-operative factories are presented below.


Organization of this factory clearly shows the I/c Managing Director is responsible person for production in the factory and administration of the staff.


The Chairman is the most important person in the sugar factory. His role is to take important decisions in the meetings of board of directors.

5.2 ORGANIZATIONAL STRUCTURE OF DECCAN CO-OPERATIVE SPINNING MILLS LTD., ICHALKARANJI

The Chairman of the factory is at top position from the shareholders side. The General Manager of the Soot Girani is responsible person in the structure.

The Soot Girani has two sides, one is production and another is administration.

Production side : In Deccan Co-operative Spinning Mills, the technical Manager is responsible person. He controls the production side of the Spinning Mill. There are four departments under his administration :


- i) Senior Spinning Master
- ii) Electrical Engineer
- iii) Civil Engineer
- iv) Statistical Quality Control Officer.

These are the departments which are concerned with the production.

The Manager (Administration) controls and supervise various departments. The accounts department, Stores department, Sales department, Typing and Dispatch, Time office, Guest House, Labour Department, Purchase Department, are under his control.

All the workers and heads of departments are related indirectly. They play important role in production of mill.

The organization chart of the Soot Girani clearly shows that the position of the officers, workers and the role of them.


The Chairman plays important role in the factory. His status is also high as compared to others.


The organization chart of Ichalkaranji Co-operative Spinning Mills is presented on page 44.

The Chairman/Vice-Chairman. The Managing Director are responsible persons for all the matters of the Spinning Mill. There are 12 departments working under the Managing Director. Those are Electrical Engineer, Spinning Master, Labour Officer, Security Officer, Civil Engineer, Horticulturist, System Analyst, Store Keeper, Chief Accountant, Excise incharge and First aid ambulance.

All the heads of departments look towards the working of their assistance and departmental activities. All the workers are related directly or indirectly to the departments as well as the Soot Girani. They are all engaged in production activities of the spinning mill.

Under his control the two important departments : The Production department and Administration department are working.



The Production Manager looks after the production of the mill. Under his supervision there are Engineers, Spinning Masters, Quality Control incnarge, Action Selector.

The Chairman takes important decisions in the meeting of Board of Directors. He is top person in co-operative processors.


The Manager is the responsible person in the processors. There are three important departments,



- iv) Accounts Section


II. The Production Department concerns with four departments :

The Managing Director controls all the departments of the factory. The factory has two sides - one is production and another is administration. The M.D. looks upon both the sides of the factory.


The organization of the factory is simple. Only three departments are under his control.
