It is clear from the above table that 10.6% (i.e. 87) of the population is under five age group within which 55.1% (48) are males and remaining 44.9% (i.e. 39) are females. This means the number of male children is more. This is also true in case of the remaining age groups except the last age-group of 45 and above where females are in majority.

The largest age-group consisting of 352 individuals is of 15-45 years range. This is supposed to be the economically active age group. Here the number of females is almost equal to that of males.

Thus, the basic features of this population are

(i) A fairly large number is of the working population.

(ii) Males are more in number than the females.

The slum-dwellers under study belong to the comparatively low-income group of the society. Excluding the small and school-going children, disabled persons and very old people, it was found that there are as many as 477 persons who are fit to be economically active. The sex-wise and occupationwise position is given in Table No. 5.
