CHAPTER - III

PROFILE OF THE SUGAR FACTORIES

3.1 INTRODUCTION:

In the industrial field in Maharashtra the business of sugar industry is very significant and sugar industry is regarded as glory of industrial life at that time they had to face the problem of poverty, unemployment etc. In order to solve these difficulties the co-operative movement became very useful and under the blessing of co-operative movement the sugar industry in India got flourished. The credit of opening the first sugar factory in Asian Countries goes to India. The first sugar factory was established at Prawaranagar in Ahamadnagar district of Maharashtra on co-operative basis. The pioneer of the first cooperative sugar factory goes to Late Padmashri Vitthalrao Vikhe Patil. The sugar factory has played an important role in the life of people belonging to this drought affected area. Prior to this at malinger one such an attempt was done by Late Heribhau Girame, but it was unsuccessful. The Maharashtra sugar industry got rally flourished for the last 45-50 years from the days of the establishment of Prawara Co-operative Sugar Factory. "Help each other", "Not me but you", become the mottos of these co-operative established sugar factories. The great leaders like Late Yashwantrao Chavan, Vasantraodada Patil, encouraged the sugar industry.

The Sangli district has well developed co-operative network in all sectors co-operative organizations. The co-operative organizations are playing very important role in the development of Sangli district and life style of the peoples in the Sangli district. In Sangli district there are 13 sugar factories these all the sugar factories are working on co-operative basis. These co-operative factories are very well supported to the financial development of the farmers in the district. These factories are provided large amount of employment to the peoples in the district. These sugar factories are also provided other services to the society like financial support, education facilities, medical facilities, sport facilities, water supply scheme. So, co-

operative sugar factories are playing very important role in the overall development of the Sangli district.

In the present research work the researcher has selected two co-operative sugar factories in the Sangli district. These are providing good service in their operational area. These sugar factories are played very important role in the development of life style of the farmers. These two co-operative sugar factories are one is HKASSK Ltd. Ltd; Walwa, which is established in walwa taluka district Sangli and another one is KSSK Ltd. which only one sugar factory in Plaus taluka district Sangli. The brief information about these two selected co-operative sugar factories are given in the profile of these two sugar factories, which given idea about the performance and working practices of these two co-operative sugar factory in Sangli district.

3.2 HUTATMA KISAN AHIR SAHAKARI SAKHAR KARKHANA LTD.WALWA: (HKASSK Ltd.)

3.2.1 History of Sugar Factory-

The HKASSK Ltd.has established a very significant position in the sugar industry business in Maharashtra. The Karkhana is situated at walwa in the Sangli district of Maharashtra. The village walwa is at a distance of 10 km. from Islampur. The Sangli district comprise nine talukas and walwa is one of the taluka near the HKASSK Ltd.a feeder flows of Krishna river. The Board of Directors of the HKASSK Ltd.has run the sugar factory very efficiently with the help of employees and shareholders. At the same time as a part of social commitment it has encouraged to attract kids towards education and to utilize education as a means of progress, the factory has started totally thirty nursery schools in its work field. The factory also provided health maintenance facilities and medical assistance to its members, workers, and other peoples in the operational area. For the continuous supply of sugarcane the factory executed many water surply schemes, sugarcane investigation and development schemes, supply of agromin and bio-gas grant schemes etc. the guidance is given to the farmers for the increase the production of sugarcane by factory. The factory has earned name by enlisting a good sugar production

record. It is a by thing of proud to mention have that the factory is well known for giving to the sugarcane products highest rate in India.


The founder of the factory is neither a member nor chairman nor a director of the factory and affix the completion of every five year term there is a position of changing both directors and chairman. Indeed due to these new method adopted the factory has been successful in maintaining the record of high production of sugar all over India for the last ten years.

3.2.2 Establishment and Registration of the Factory:

HKASSK Ltd. was established on 28th Jan. 1984 under the leadership of Hon. Shri. Nagnath Naikawadi for the development of the sugarcane farmers. As per the recommendation done by the government of Maharashtra the HKASSK Ltd. got approval from the Government of India on 26th March 1981 vide application No. is L.I. 125(B) 389/78. The factory was duly registered as per the Maharashtra Co-operative Act, 1960.

The factory has got the industrial approval on 28th Jan. 1984; the industrial approval no. is C.I.L. 26(84), New Delhi. The boiler of the factory was lit up at first on 29th Jan. 1984.

3.2.7 Objectives of the Sugar Factory:

The HKASSK Ltd.is established to the development of the farmers and for their growth by providing well return to their production. The sugar factory has fulfilled the various objectives in respect of the society are as follows:

- 1) To give the good market rate to the farmers who supply the sugarcane to the factory.
- 2) To keep the good relations with the customers and farmers and to maximize their satisfaction.
- 3) Maximum utilization of manpower and production capacity and proper utilization of raw material for good recovery.
- 4) To increase sugarcane and agriculture production by using scientific method of agriculture production.
- 5) To promote the economic and social betterment among the members through self-help and mutual aids in accordance with the co-operative principles specified in the first scheduled of the act.
- 6) To encourage self-help, thrift and co-operation among members.

- 7) To providing finance to the farmers at minimum interest rate for their development.
- 8) To supply water for the agriculture sector by introducing various water supply schemes.
- 9) To manufacture sugar and their byproducts out of sugarcane grown and supplied by members of the society and other to sell the same to the best advantage.
- 10) To undertake such other activities as are identical and conductive to the development of the society.
- 11) To acquire and install machinery for the utilization of the byproducts and buy raw material and sell finished product in the course of utilizing and marketing the byproducts.
- 12) To improve the recovery rate of sugar production by using different verities of sugarcane and other techniques of production to increase the profitability.

3.2.9 Other Services or Facilities Provided By Sugar Factory:

The HKASSK Ltd. has provided other facilities and services to the shareholders, workers and also to the society.

3.2.9.1 Provided fertilizers to the farmers:

The HKASSK Ltd. has provided fertilizers to member farmers at lower rate. It is helpful to the farmers for increasing the production from their farm because of fertilizer are available at lower rate and on credit basis the profitability of the farmers are also increased and they can earn more profit by increasing the production.

3.2.9.2 Sugarcane conferences and sugarcane development workshops:

The HKASSK Ltd. has organized the farmer's conference and sugarcane development workshops with the support of Agriculture Universities and Vasantdada Sugar Institution, Pune every year. In this conference the experts are given information to the farmers about new technology, new sugarcane seeds, about the water management. This conference and workshops are helpful to the farmers in the increase the sugarcane production and it is also improved the financial position of the farmers. This one very important activity was introduced by this sugar factory for the development of farmers in the area of operation and lots of farmers are benefited by this conference and workshops.

3.2.9.3 Water supply scheme:

The sugar factory has started various water supply schemes for the agriculture sector in the area of operation for this water supply schemes the sugar factory has taken finance from the banks also from the sugarcane development funds; own funds of the sugar factory are also used. At present this water supply schemes has provided water near about 8643 acre area of agriculture sector, because of this various schemes lot of area of agriculture sector has under the irrigation. TheHKASSK Ltd. has started near about 50 water supply schemes in it area of operation and near about 5500 farmers are benefited by this water supply schemes.

3.2.9.4 Education Development:

This sugar factory has given very important contribution in the development of education facility in the area of operation. The sugar factory has given awards to the students for given motivation to them. The sugar factory has also started sugar school to the children's of the sugarcane cutlers in the factory place. Schools and colleges are also started by the sugar factory.

3.2.9.5 Workers welfare schemes:

In the sugar factory all workers are the members of the Maharashtra workers welfare association, Mumbai. They have provided various facilities by the association and sugar factory for their financial development. The sugar factory has himself given same contribution about finance to this workers welfare association. From this association facilities are provided to the workers and their family like medical support, educational support, scholarship to the students of the workers.

3.2.9.6 Computerized System:

In 21st century the every work is done by the using advanced technology. The sugar factory has also introduced computerized system in their regular working. At present in sugar factory share, agriculture, deposit, fertilizer, seeds, ken account department work done by using computerized system, also storage account and sugar account are also done by using computer. The computerized system increased the acquiresof the work and it is done in less time, so it is more profitability to the sugar factory.

3.2.10 The Factory and Relations With Labors:

The labours are the asset of the factory. The success of the sugar factory had been largely depending upon the quality and performance of the workers. The sugar factory has also given various facilities to the workers; they get good salary and accommodation facilities from the factory that's why the relations between the sugar factory and labours remain good. It is very helpful in the development of the sugar factory.

3.2.11 By Products of Sugar Factory:

The HKASSK Ltd.has produced different by products. These by products are increased the profitability of the sugar factory.

1) Distillation:

The unit uses molasses, which is waste the production of sugar, as raw material for distillation. These molasses has about 40 % to 45% of sugar in it.

2) Bagasses:

The fibrous material of sugarcane which is after extraction of juice comes out from mill house is called bagasses and is used as fuel for boilers. In HKASSK Ltd. use the bagasses for high pressure boilers to generate steam. Thus generated steam is used to produce electric power by using extraction turbo generation set.

3) Press MUD:

The press MUD is obtained in the produce of sugar production. It is used as manure. The HKASSK Ltd.has the sold press MUD to the farmers.

KSSK Ltd. was located at Kundal, Tal: Palus, Dist: Sangli. The Kundal is villages which have large area of sugarcane production and having good facility of water supply for the agriculture sector. Kundal is the village near about Palus by 5 km. west of the Palus taluka. The Palus taluka is well

developed by industrial movement. There is lot of industries in Palus taluka. The KSSK Ltd. is only one sugar factory in Palus taluka. The KSSK Ltd. has given very important contribution in the development of the Palus taluka.

The KSSK Ltd. was established under the guidance of Krantiagrani Dr.G.D.Bapu Lad. This sugar factory is his dream and he makes lot of efforts for the establishment of this sugar factory. Now days this sugar factory is one of the leading sugar factory in Maharashtra in less time for the supply of continuous and good quality sugarcane the sugar factory established various water supply schemes for the agriculture sector in the area of the operation. In the year 2011-2012 the sugar factory has completed 10 crushing seasons successfully from the establishment the sugar factory has given good return to the farmers and shareholders so that the sugar factory has achieving well status and goodwill in the society. The sugar factory has using 100% or more than that crushing capacity from the establishment, so the factory is having good position in respect of profit and other operational management.

3.3.7 Objectives of the Sugar Factory:

The specific objective of the KSSK Ltd. has been given as follows:

- 1) To encourage proper development of agricultural industry amongst the members on co-operative lines by introducing modern methods of agriculture and by promotion of principles of co-operative and joint farming method so as to secure best advantages of modern large scale agriculture production.
- 2) To adopt scientific methods of agriculture production to increases sugarcane and agricultural production.
- 3) To provide the facilities for transporting and harvesting of sugarcane to members of the factory.
- 4) To establish supplementary units based on by products like bugasse, molasses and pressmud.
- 5) To make provision of irrigation schemes and execute these schemes for increased the production.
- 6) To introduce different types of schemes for all round development of members, workers, and society as a whole within the area of operation.
- 7) To provide maximum employment to the people in the area of operation of the factory.
- 8) To provide financial support to the farmers for their overall development at minimum interest rate.
- 9) To improve the recovery rate of sugar by using advanced technology.

10) To developed different new verities of sugar for improving the production of the sugar.

3.3.8 Performance of Sugar Factory:

3.3.9.1 Soil Testing Center for farmers:

The KSSK Ltd.was established a soil testing center for the farmers, where farmers can test the soil in their farm and identify which factors are required for the increasing the production. This center was established in the year 2007.

This was provided by the Agricultural Minister of India, Hon. Sharadchandraji Pawar. After the establishment of soil testing center the farmers can take production from the farm in less water, fertilizers and in minimum cost. So this center is very useful for the farmers to make a profitable farming.

3.3.9.2 Sugarcane Development Program:

From the establishment of the sugar factory the Karkhana was introducing the sugarcane development program for increasing the sugarcane production for that purpose they are stared the various schemes and programs, which is providing various qualities sugarcane seeds to the farmers, providing financial help to the drip irrigation schemes, provided fertilizers to the farmers at minimum rate on credit. This program helped in the increasing the production of sugarcane in the area of the operation.

3.3.9.3 Water Supply Schemes:

The KSSK Ltd. was given important contribution in the water supply schemes in the area of operation. The sugar factory has also starts some new water supply schemes in the operational area. These schemes are Veralamai Sahakari Water Supply Scheme, Vasant Water Supply Scheme, Shivshambho Water Supply Scheme and Basaveshwar Water Supply Scheme. These schemes supply water for the agriculture sector in the area of operation of the sugar factory, which is helped in the increased the production of sugarcane.

3.3.9.4 Accident Insurance Policy Provided to the Shareholders:

The KSSK Ltd. was started accident insurance policy to the shareholders of the factory. This insurance policy scheme was started from year 2009-10 under this policy the shareholders have given insurance benefits up to Rs. 1, 00,000/- from the sugar factory. This policy is very useful to the shareholders in the financial problems for medical treatment in accident time.

3.3.9.5 Sugar School:

The sugar factory has provided every year sugar school facility to the children's of the sugarcane cutting workers. Sugar factory management and Plaus local authority together starts this scheme for the education of the labours Childs. In this sugar school class are taken from 1st to 6st in which 80 students are taken education, so because of this sugar school the education

need of the workers children are completed and they can also take education at free of cost.

3.3.9.6 Computerized System:

The KSSK Ltd. has used computerized system for its establishment. In modern world the computerized system is very important for the down work in time at acquire. The sugar factory has made all the departments computerized like, production department, sales department, account department, stock department, etc. because of the computerized system; the work is done in time. The profitability of the sugar factory is also increased.

3.3.9.7 Provided Fertilizers to the Farmers:

The sugar factory is given fertilizers to the farmers according to the requirement of the crops. The sugar factory has given guidance to the farmers for the using which types of fertilizers in the farm for increasing the production. The fertilizers are available to the farmers at minimum price to the farmers and they have also provided credit facility to the farmers. The production of sugarcane is also increased after the availability of fertilizers in time.

3.3.10 Sugar Factory and Labour Relationship:

The KSSK Ltd. was provided the accident insurance policy around 2 lakh to 4 lakh of all the workers, employees and officers in the factory. The sugar factory also provided quick medical services from Dr. Pratap Kulkarni, because of all the efforts taken by the sugar factory the relationship with workers are very good. The contribution of the labours in the production and profitability of the factory so management has given regular bonus to the workers of the factory.

3.3.11 By Products of Sugar Factory:

The KSSK Ltd. has produced different type of by products other than sugar production:

1) Co-generation Power Plant:

The sugar factory has started co-generation power plant on 16/2/2010, from the power plant project t the sugar factory has produced 1, 42, 34,800 units

power in first season out of which the sugar factory has used 2789600 units power for their own use and 11445000 units power is sold out to the MSEBC ltd; form that factory has earned Rs. 5, 47, 85,880/-

2) Bagasses:

The bagasses is also are by products of the sugar factory. Bagasse is used by the sugar factory for the fuel of the boilers. The sugar factory has earned income from the sale of the bagasses near about Rs. 4, 50, 00,000/- every year. This is helped in the increased the profitability of the sugar factory.

3) Press mud:

The press is obtained in the sugar factory in the process of sugar production. The press mud is used in the farm for the increased production. The sugar factory has sale near about Rs. 35, 00,000/- press mud to the farmers every year.
