INTERPRETATION AND ANALYSIS OF DATA

This Chapter is mainly connected with data collection and its interpretation. The main theme of this chapter is workers attitude towards welfare facilities.

I had gone through the welfare facilities provided by Kirloskar Brothers Ltd. Kirloskarwadi factory. After considering the actual observation and opinion, survey of worker regarding welfare facilities, following table are drawn.

The above table shows that a large number of workers i.e. 33 % are between the age group of 40 to 45 year. And that 24 % of workers belong to age group of 35 to 40 years. And 20 % of workers belong to 45 to 50 range. While a few 7 % of workers remains in the range of 50 to 55 age group year.

It means that the company has given preference to efficient and active workers at the time of recruitment. Because 70 respondents i.e. 93 % workers are 25 to 50 years of group.

Therefore, it can be said that the company is having young and efficient force.
