CHAPTER-III

LAND ACQUISITION AND REHABILITATION

Any irrigation development scheme has two aspects economic as well as social. The economic aspect includes the cost of construction of the dam itself, canals masonary work, mechanical work, construction work of canal banks etc. The social aspect include mainly the problems submergence of land, land acquisition and rehabilitation of the dam affected villaces as well as families. It can be said that the economic benefit of the irrigation scheme can be discribed in terms of irrigation potentional, change in cropping pattern, increase in food production, modernisation of agriculture and thereby overall increase in standard of living of the rural families. Though this economic effect is on bright side of the coin, should be remembered that this economic benefit has always social cost defined as the cost of sacrifies of the submergence of some villages and instability of the dam affected villages and families as well. Therefore the problem of rehabilitation of the dam affected villages and also families must get equal proirity in the economics of development of major irrigation projects.

This chapter deals with a study of rehabilitation work of Bhima (Ujjani) irrigation project. Irrigation

project in respect of submergence and acquisition of land, Organisation and administrative machinery of rehabilitation work and its progress. The land acquisition and the rehabilitation are equally important issues of the major irrigation projects.


3.1 LAND ACQUISITION:

In order to acquire the required quantity of land, it covers six talukas in three districts of Solapur, Pune and Ahmednagar. The total land acquired for construction of Bhima (Ujjani) Irrigation project was 27534 hectares (see table No. III.1) out of which 26595 hectares was privetly owned land and remaining land owned by the government which is reserved as forestlland.

It is evidently clear from the table No. III-1 that the maximum land acquired under the dam comes from only two talukas in Solapur District.

Acquisition of private land is the most difficult task it is having many social, economic, political and legal complications. The government has to pay compensation to the private land holders as per law. The total amount paid to the private land owners as compensation was Rs. 6,43,03,524 during the last 12 years from 1968-69 to 1979-80. The maximum amount of more than Fs. 4.47 crores was paid in the year 1975-76. Regarding acquisition of gaothans. Out of 51 submerged villages 34 villages were submerged was one year of 1975-76. The total amount of compensation paid for the gaothans acquisition was more than Rs. 2.75 crores during the period of 10 years from 1970-71 to 1979-80.

The table No. III-3 gives further details about the submerged villages in Madha and Karmala taluka in Solapur District. The following observations can be made.

- 1) The total land of more than 13846 hectares were acquired in both Madha and Karmala talukas and the total affected population was 25376.
- 2) Out of four villages in Madha taluka the maximum land of 478.40 hectgres of Surli village was acquired.
- In Karmala taluka, out of 19 villages the maximum land acquired comes from Chikalthan village 1548 hectares, wangi village 1474.31 hectares and Bitargaon village 1149 hectares.
- 4) According to size of population Shiral village in Madha Taluka (1257) and Wangi village (4646) and Chikalthan village (2602) in Karmala Taluka were badly affected.

3.2 REHABILITATION:

The lake formed due to construction of Ujjani Dam has been spread in three district viz. Solapur, Pune and Ahmednagar. Total submergence are of 29000 hectares and about 6918 hectares of land coming under canal construction, 51 villages have come under submergence. The ditrictwise break-up of villages under submergence are as under.

The submergence included the portion of Pune, Solapur Section of Central Railway (34,47 km.) Pune-Solapur section of National Highway No. 9 (16 km), portion of Ahmednagar-Vijapur Road of State Highway No. 32 (32 km.) and trolly line portion (65 km) of Walchand Industries Limited, Walchandnagar in Pune District.

The acquisition of the 51 villages coming under submergence already has been completed. Out of 51 villages resettlement of 50 villages is completed. The resettlement of remaining one village of Kavitgaon in Karmala Taluka Solapur District is in progresss through Revenue Department as the work of acquisition of this village is already completed by this Department.

The civic amenities such as water supply, electrification, approach roads, schools, community buildings
etc. are provided by the respective Zilla Parishad (Pune,
Solapur,, Ahmednagar) and the progress is monitored by
Revenue Department and it can be said that the rehabilitation
work of Bhima (Ujjani) project is practically completed.

The rules regarding rehabilitation newly formed in the year 1976 are also not applicable to this project as the project has commenced prior to 1976. The allotment of alternate lands in the benefitted zone to project affected persons after taking lands from private negotiations vide Government Irrigation Department, Maharashtra Bombay's Marathi letter No. Rah-1086/2513/(246/86) Maj. Project(1) dated 7-10-1986. However the allotment of alternative lands in the benefitted zone to project affected persons in being done by Revenue authorities for government lands.
