My dear Rao Bahadur, Surve,

With reference to the correspondence ending in your D.O. letter No.116 dated August 2nd, 1931, I am to say that I have received a letter from Dr.Velte, the Secretary of the India Council of the Presbyterian Mission of America informing me that although the formal sanction of their Home Board was not received, yet, from the correspondence that was held between them, it may be taken that the necessary permission was given and I have been asked to go forward with the arrangements of full-time services of Mr.Goheen.

I am anxious to have the arrangement proposed by me regarding the administration of the Jahagir should be approved by the Kolhapur Darbar as early as possible so that I can proceed with the arrangements of the proposed over-sea trip to a bracing climate. I request however that in the arrangements that would be approved for carrying on the administration in my temporary absence, the administrator should not cease to be responsible to me also, because I do not wish to entirely lose touch with the administration of my Jahagir. As the Darbar

aware, I had taken long holidays twice before once & for about 11 months in 1913 and again for 7 months in 1919. On both these occassions, during my absence from home, I was in touch with the affiars of the administration and I wish to do the same on the present occasion. Although Mr.Goheen may be fully responsible in my absence for the administration to the Residency and the Kolhapur Darbar he should also be under my direction and guidance as on former occasions. Moreover, both on account of financial stringency and other considerations, I am afraid, it will mix not be possible for me to be besent from Ichalkaranji very long. And during the periods, I shall be at Ichalkarani or near about, I can continue my interest in matters of public welfare and utility in my Estate. I would, therefore, crave His Highness indulgence for permission to delegate my powers to Mr. Goheen as was done on the last two occasions in 1913 and 1919. I enclose herewith for ready reference copies of Darbar's orders passed on the previous two occasions and I shall feel obliged if you can kindly induce His Highness the Maharajasaheb to accord his permission by the use of a similar formula on the present occasion also.

Hoping to be kindly excused for the trouble.

Shrimant Narayanrao Govind alias Babasaheb Ghorpade, Pant Sachiv, a Kokanastha Brahmin, is the present Jahagirdar of Ichalkaranji, was born in 1871 and succeeded to the Gadi by adoption in 1876. Received his education at the Rajaram College, Kolhapur and the Elphinstone and Law College, Bombay was invested with the powers of his Jahagir in June, 1892. Since his investiture, he has introduced many reforms in his Jahagir. Primary education is made free and the agrigultural Forest and Educational departments have been greatly improved. Takes a keen interest in the co-operative movement and has encouraged the development of Co-operative Societies in the Jahagir. A Gentral Co-operative Bank has been started for financing trade and agriculture. Is a First-class Sardar of the Deccan and as such represented the Sardars and Inamdars of the Deccan in the Bombay Legislative Council for twelve years. Has travelled extensively and visited Burma, Malaya, Peninsula, and Jawa and England and the continent three times. Has published in 1913 his " Impressions of the British Life and Character ". Has also written some books in Marathi. Has a special liking for riding, hunting and Music.

Account of Ichalkaranji Jahagir.

The Jahagir of Ichalkaranji comprises an area of 240 square miles with a population of 60,366 according to the census of 1921. The revenue of the Jahagir based on the average of the last three years is Rs.4,53,251/-. The Jahagirdar of Ichalkaranji is also a first class Sardar of the Deccan.

Narayanrao Govind alias Babasaheb Ghorpade, Brahmin is the present Jahagirdar of Ichalkaranji a Feudatory Estate under Kolhapur was born in 1871 and succeeded to the Estate as adopted son of the late Jahagirdar in 1876. Was aducated at the Rajaram College, Kolhapur and at the Elephinstone College, Bombay, Was invested with powers in June, 1892 by the Political Agent on behalf of H.H. (His Highness) the Maharaja of Kolhapur. At the time of his investiture, the Jahagir was encumbered with debt which was soon discharged by his able management. Careful attention has been paid to all the departments of Jahagir and expenditure on education and Medical services has been more than doublted. Has founded many scholarships for the education of his subjects. Represented the Sardars of the Deccan for 12 years in the Bombay Legislative Council both before and after the Moræey Monto Reforms. Has travelled widely visited England

twice and has written and translated useful books. Has a grandson Shrimant Keshavrao Tatyasaheb, who is 9 years old and is studying 1st English standard.
