Being a follower of Gandhi and true congress-man he contested first public election in 1946 and got elected to the Bombay legislative Assembly. From 1946 to 1962 he remained in the politics of Maharashtra and latter on going to the centre where he became Defence, Home-Finance and foregin ministers and opposition leader.

The highest post occupied by Yashawantrao Chavan was Deput, Prime-Minister of India in 1923. He passed away on 24th, November, 1984, when he was sitting member of Parliament.

Thus many years Yashawantrao remained power politics of this country but he spent his whole life for the betterment of common man. Here in this work and attempt has made to study his work as a Chief-Minister of Bombay State and Maharashtra State by using original source, such as Bombay Legislative debates, speeches, reports etc. This is a descriptive cum interpretative study.
