

## CHAPTER - 6

### SHARE-HOLDERS AND DEVELOPMENTAL ACTIVITIES OF CO-OPERATIVE FACTORIES

#### 1. INTRODUCTION

The co-operative factories are based on the contribution of the share-holders. These sharenolders purchase shares from the factories and also supply raw material for same factories. The financial situation of the co-operative factories depends on the response of the sharenolders and the shares they purchase. The Government also assists these factories by purchasing some shares. Thus the share-holders play a crucial part in the establishment of the co-operative factories.

The shareholders got the benifits of these co-operative factories in the sense that they supplied raw material to these factories and received higher prices for their raw material. The exploitation of shareholders was also ceased due to this process.

The factories have implemented different developmental activities in their area of operation. These activities are beneficial to the shareholders and others.

The present chapter deals with the information about sharenolders and the development activities by tnesse co-operative factories.

#### 2. PANCHAGANGA

The details of shareholders, total shares and share capital of Panchaganga are presented in Table 6.1

In year 1958-1959 the shareholders of Shri Panchaganga Sahakari Sakhar Karknana Ltd., Ganganagar Ichalkaranji was 1659 and the total shares were 4044 and the share capitals is Rs. 25.18 lakhs. In the year 1985-86 the total shareholders were 14048 and the total shares were 26932 and the share capital was Rs.256.70 lakhs. From the table it can be said that the number of shareholders have increased, the total shares and share capital has also increased with the exception of 1969-70 and 1970-71.

In year 1968-69 there were only 6033 shareholders and the total of shares were 17016. In year 1986-87 the number of shareholders increased upto 12933 and the total shares upto 37751.

The number of shareholders and shares has constantly increased. The share capital in 1968-69 was Rs.14.27 lakhs, which has increased in 1986-1987 to Rs. 183.21 lakhs. The share capital has also constantly increased. Thus the table indicates sound financial situation of the factory.

In the year 1977-1978 there were 2145 shareholders and the total shares were 13592.

In the year 1987-88, the shareholders have increased upto 3037 and the total shares upto 27843.

Thus the shareholders and the total shares have constantly increased. The share capital was Rs.135.92 lakhs in 1977-1978 and it has increased in 1987-88 upto Rs.278.42 lakhs.

In the year 1980-81 there were 3027 shareholders and the total shares were 9363. In the year 1987-1988 the number of shareholders has increased upto 4703 and the total share have gone upto 162495.

There are 102 villages in area of operation of Panchaganga from five talukas, viz. Hatkanangale, Snirol, Kagal, Karveer in Kolhapur disdtrict of Manarasntra State and Chikodi taluka from Belgaum disdtrict of Karnataka State.

This table shows the expenditure incurred by the sugar factory on various schemes. The educational and cultural development activities carried out by the factory. These activities are like financial help to students in poverty stricken area, constructing house for homeless labourers, assistance to Chief Minister's fund, assistance to Prime Minister's fund, donation given by eye camp, family planning camp and Panand roads, etc.

The total amount spent on social, cultural and development activities as on 30-6-1988 was Rs.294.15 lakhs.

13. DECCAN CO-OPERATIVE SPINNING MILLS LTD.

13.1 DECCOSPIN Charitable Trust

The Deccan Co-operative Spinning Mills established the Deccospin Charitable Trust. Through this Trust the weaker section and backward class people have been improved.

The Trust has established the co-operative Life-Irrigation Schemes and dug bore wells. The Trust had a dairy project at Minche, for the welfare of the Ramosni tribal people. The Trust have established monteseries at villages. The Trust pays the wages of teachers and spends on this education programme.

The following table presents the activities of DECCOSPIN Trust.

The above table indicates that a total amount of Rs. 23 lakhs financial assistance has been issued by the Trust. The table also indicates that nearly half of the assistance has been allotted to housing programme which is followed by agriculture. The Trust has also rendered assistance in the schemes of industry <sup>technical</sup> education.

### 13.2 DECCOSPIN Research Foundation

This Foundation works for the assistance of power-loom owners. Foundation analyzes cotton and gives technical information of the cotton.

## 14. KOLHAPUR ZILHA SHETAKARI VINKARI SAHAKARI SOOT GIRANI LTD.

### COTTON DEVELOPMENT

The mill started cotton development scheme in 1968 to promote cotton cultivation in its area of operation viz. Kolhapur District. The mill has given every facility to its cotton grower members such as supply of improved and high yielding varieties of cotton seeds, plant protective chemical, manures, hand and power sprayers and other requisite inputs at subsidised rates. The Mill has also given incentives to grower members per share as - 1980 Rs.400/-, 1981 Rs.300/-, 1982 Rs.160/- and 1983 Rs. 225/-.

## 15 THE ICHALKARANJI CO-OPERATIVE SPINNING MILLS LTD.

### 15.1 Area Development and Social Welfare

As a successful co-operative organisation ICCO SPIN accepts the responsibility to give impetus to promote allround development of the

neighbouring area and to exert for betterment of backward class people and economically weaker section of the society. At the same time, it is desired that any developmental programme so undertaken should not affect financial position of ICOSPIN. So a separate Vikas Foundation has been created for utilization towards agricultural, educational, cultural, industrial activities etc. As such, Textile Technological Institute and hand-loom projects are receiving immediate attention.

### 15.2 Textile Institute

Dattajirao Kadam Technical Education Society has started Textile Institute during academic year 1982-1983 which offers four year Diploma courses in Textile technology. The course is on the lines of D.T.M. of Board of Technical Education or L.T.M. of V.J.T.I. and it will meet to a great extent the present need of technically trained persons in various textile units. The society has to bear recurring and non-recurring expenditure for the course. Shri K.B. Awade had taken initiative in starting this Institute and he received assistance from people of Ichalkaranji, Co-operative Sugar Factory and others in this task. Thus, the Co-operative Spinning Mills have also contributed to the field of technical training.

### 15.3 Handloom Project

Ichalkaranji and its neighbouring villages namely Rendal, Yalgud Hupari etc. were once well-known for handloom centres. However, handloom weaving has now become almost extinct in this area. It is, therefore, desirable to revive this industry which has got a great

potential for large scale employment. Hence an independent Co-operative Shri Lakshmi Gramin Hat Mag Vikas Sanakari Society Ltd. has been registered on 18th January 1984. The Mill shall extend all preliminary technical as well as financial assistance and help in establishing the project at village Jangamwadi, Taluka Hatkananagale, District Kolhapur. After finalisation of plans, and estimates, construction of handloom shed has been started.

#### 15.4 Housing Society

Most of the workers of the Mill came from neighbouring villages. These workers prefer to live at their respective villages rather than to shift to the mill colony because they are concerned with agricultural activities also when got on duty in the mill. More over, land is cheaper and easily available at villages rather than neighbourhood of the mill. Hence the scheme is envisaged for construction of houses at respective villages of the workers. The Mill is monitoring the said scheme with the financial assistance of banks. After completion of various preliminary formalities three houses have been constructed at village Rendal. Construction of similar types of houses in other villages shall be undertaken.
