# 2.1 THE ORIGIN OF SHETAKARI SAHAKARI SANGH LIMITED

decade 1930-40, there World During the was Depression. Many agriculturists from this area were practically dependent on local moneylenders and dalals (commission-agents). The underprivileged and illiterate farmers were fully exploited and kept in the clutches of moneylenders. The were co-operative organization was the best medium to free such debt-ridden agriculturists from such rapacious local moneylenders and dalals.

In 1939, Madhavrao Bagal and Ratnappa Kumbhar started "Kolhapur State Prajaparishad Movement" for the welfare of the common agriculturists. Thanks to this movement, Kolhapur State Darbar had to concede some concessions in <a href="Shetsara">Shetsara</a> (land revenue).

But the agriculturists were not fully satisfied with the concessions in land revenue. As a countervailing force to Prajaparishad, the people loyal to the late Chhatrapati Maharaj started another movement, "Rayat Sabha". The first meeting of Rayat Sabha was held at Kadamwadi and there was a proposal to start a farmers' co-operative marketing society. In the meantime, Varna Valley Marketing Sangh was opened in Shahupuri

Peth, but this Sangh failed to achieve its objectives, because the agriculturists did not know the method of working of a organization. S.S.Sawant of Gotkhindi co-operative P.D.Jadhav of Kameri met P.A.Rane and M.S.Todkar. S.S.Sawant had studied the psychology of the agriculturists. According to his considered opinion, only delivering lectures to the agriculturists would not serve the purpose of the welfare of the agriculturists. An effective instrument for this purpose, according to them, was to organize one Shetakari Sahakari Marketing Sangh at each Taluka to promote the economic interests of the agriculturists by securing better returns for their produce and making available to them agricultural inputs and to replace the moneylenders and the dalals. Rao Bahadur S.S.Shirke, the Registrar of Co-operative Societies and Phaterfekar also concurred with this opinion and thanks to the efforts of P.A.Rane, M.S.Todkar and D.R.Bhosale, V.T.Patil, Mamasaheb Minchekar, Bapusaheb Rajadnye, A.G.Jamsandekar, D.S.Mane, G.G. Jadhav and others, the "Shetakari Sahakari Marketing Sangh Limited, Kolhapur" was established in the Princely State of Kolhapur on 23rd October 1939. Bhaskarrao Jadhav and Dr.P.C. Patil had given moral support and guidance to the establishment of this Sangh.

B.D.Kagle, S.V.Patil, Rangrao Bhosale, Dada Haladkar, the employees of the Co-operative Department, and Bapusaheb Jagtap, V.G.Pol, S.B.Bhosale, V.A.Kadam, Sarjerao Patil, H.B.Hawal, V.N.Ghorpade, S.R.Jadhav and some other prominent persons from different fields of social life took

great pains to continue the activities of the Sangh. Bapusaheb Rajadnya was the Honorary Organizer. He was an expert in cooperative principles and co-operative law. Under his guidance, the Sangh's organization was set up. The late Chhatrapati Sahahaji Maharaj, Col.Khanvilkar, Keshavrao Nikam, Bapusaheb Pawar, Bapusaheb Jagtap, Capt.A.B.Bhende, Murlidhar Navare, P.D.Jadhav, Govindrao Korgaonkar, Mamasaheb Mahagaonkar, N.G.Nigudkar, Tatyasaheb Mohite, V.D.Desai, D.N.Savant, Rao Saheb S.B.Jadhav, B.D.Kagale, D.D.Patil, Kshatra Jagadguru Maharaj, N.G.Desai, made concerted efforts to maintain and develop this Sangh.

The Sangh was actually registered as "Shetakari Sahakari Marketing Sangh Limited, Shahupuri, Kolhapur", but it became popular as "Shetakari Sangh". Therefore, the name was changed as "Shetakari Sahakari Sangh Limited, Kolhapur" in 1939.

P.A.Rane, a retired Government servant, was the President of the Sangh and was looking after the Sangh's management since 31.10.1939. He resigned his post due to ill-health and Dr.G.R.Pawar was elected President. At the same time, Todkar also resigned from the post of Managing Director and Tatyasaheb Mohite was appointed in his place.

During the initial period, the Sangh undertook the sale of agricultural produce, fuel-oil, ammonium sulphate, fish-manure, oil-cake, etc., on a moderate scale with its limited financial resources. Because of the insufficiency of capital,

coupled with large incidence of overdues, the Sangh could not make much headway during the first few years. The overall progress was slow. For its survival, the Sangh had to fight against many odds and numerous difficulties concerning finance, competition, organizational deficiencies, vested interests, etc.

It was during this crucial juncture that T.G.Mohite took upon himself the responsibility of revitalizing the affairs of shouldering responsibility as the Sangh by the Managing Director. He was a man of imagination and rare resourcefulness with high aspirations and tremendous drive. Under his directorship, the Sangh started a crusade against the defaulters and recoveries were effected in an efficient manner. The Sangh was his life's mission. He devoted all his time, energy and talents to serve the Sangh and took up the responsibility of managing its affairs with the co-operation of the Board of Directors. He, with his vision, imagination, initiative and drive, enthused energy in the working of the Sangh and laid it on a sound footing during his tenure of seventeen years.

The number of membership of the Sangh is 41,354 'A' Class individual members, 1,002 'A' Class society members and 10,405 'B' Class members, in the year 1986.

Shetakari Sahakari Sangh Limited, Kolhapur, is in the trade of utensils too from the year 1963. It started with one shop in Kolhapur City and at present, it has one more shop in Kolhapur and one at Ichalkaranji and about 12 shops at different places in the district. The total turnover of these shops is well over Rs.1.33 lakhs at the close of 30th June, 1985.

desired under 20-Point Economic Programme, prominence was given to streamlining the public distribution essential commodities of mass consumption at reasonable rates. To substantiate this ideology, setting up of the consumer under centrally-sponsored goods industries schemes was undertaken by the management of the Sangh. It started with a fertilizer unit and then turned upto the manufacture of aluminium utensils to take up a good opportunity to full its standing desire long to extend one more service to its consumers.

The date of inception of the Bhandi Karkhana of Shetakari Sahakari Sangh Limited, Kolhapur, is 17th February 1980. The production capacity of the Bhandi Karkhana is 1.0 metric tonne per day and 300 m.tonnes per annum.

Office-Staff Manager, Asstt.Manager, Accountant, Timekeeper, Godown-keeper, Clerk, peon.

Minimum wages are given according to their grades and dearness-allowance and according to the rates of Utensils' Manufacturers' allowance, which is published terminally. The rate of Dearness-Allowance is same to all workers.

Wages are calculated as under:

Minimum ages + Dearness allowance, i.e. Rs.19.05 +

Other allowances (washing and tea Rs.2.11) + House

rent Rs.30 (monthly).

Only the spinners are treated as Daily Piece Rate workers. For easy calculation, the norms are fixed according to the size of spinning vessels for 1 kg. Wages of piece rate workers are calculated as:

Fixed rate + Minimum wages + D.A. + Other allowances.
